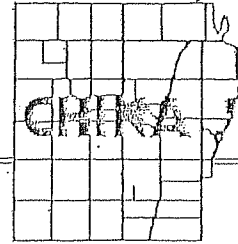

The above schedule does not include review by the Township Engineer, Township Planner, Township Attorney, or Special Engineer (traffic, environment, etc.). If a plan requires this type of review, the applicant shall reimburse the Township for the full cost of said review, BEFORE any permits are issued by the Township for the proposed use. Prior to plan review, the applicant shall deposit with the Township an amount sufficient to cover the cost of any needed reviews, with said amount being determined by the Township Clerk. If the actual cost of the reviews exceed the amount initially deposited, the applicant shall reimburse the Township for the balance of the cost prior to issuance of any permits for the project. Unused deposits shall be returned to the applicant upon final completion and inspection of the project.

Note: Where septic fields are to be utilized, the septic permit (issued by the St. Clair County Health Department), shall be in place and the approved design and layout of said field shall be shown on the site plan prior to the site plan being accepted for processing.
